

## **Board of Equalization**

## **Board of Commissioners**

Emergency Manager Nic Kemnitz reported that a 300 and 400 level class on incident command will be hosted by the region in September. The class will be held in Wayne and is limited to thirty participants.

One of the applications for FEMA disaster funds has been submitted and the second one is in the final stages of preparation.

Kemnitz will be attending training on computer software for chemical release zones. The board agreed to pay for two nights lodging.

County Court Clerk Magistrate KimBerly Hansen reported she had found a gun safe that could be used for fire-proof record storage. Structural weight limits in the county court office were questioned; it was noted that part of the office sits on top of a vault. Jeff Morlok will be contacted to look at a vent concern.

Hansen also discussed lock repair or replacement for file cabinets and doors.

Sheriff Janssen reported finding another bidder for his data processing upgrade but did not have their proposal yet.
